Injury Liability Waiver Form / Hold Harmless Agreement

WHEREAS, as a consideration for providing the basketball skills clinics, tournaments, raffles and practices, the parents of participating child agree to indemnify and hold harmless the Southwest Youth Basketball Organization, Ltd. and the Green Bay Public School District and all of its members, employees, schools, representatives and successors from any and all claims, losses, damages or expenses of any kind, including legal expenses, in the event of an accident or injury to themselves and/or their respective children.

NOW, THEREFORE, in consideration for the undertaking of the Southwest Youth Basketball Organization, Ltd. herein stated and for other good and valuable consideration, the undersigned parents of participating child hereby agree to the following terms and conditions and upon no other conditions. The undersigned parents of participating child agree to indemnify and hold harmless the Southwest Youth Basketball Organization, Ltd. and the Green Bay Public School District and all of its members, employees, schools, representatives and successors from any and all claims, losses, damages or expenses of any kind, including legal expenses, rising out of the operation of the basketball skills clinics, practices, and tournaments in which the child participates, including, but not limited to, claims for personal injuries, death or property damage. The Southwest Youth Basketball Organization, Ltd. and the Green Bay Public School District and all of its members, employees or agents do not guaranty or make any representations concerning the safety, suitability or legal sufficiency of any equipment or property upon which the activity will be held, but only agrees there under to permit the child to use the aforesaid items at the location at which the activity will be conducted, and the undersigned parents of participating child accept all risks associated with the use of the equipment and facilities.
